Any person nominated for a Life Membership must already hold a Netball North Harbour Service Award. A minimum 15 years' service is also required.

*Material provided for a Service Award may be provided as background material when a nomination for a Life Membership award is being made. That material will be considered part of the nomination, however, the award of a Life Membership requires an **“additional and significant contribution beyond that which was the basis of a Service Award”***

Nominations will be assessed on the following criteria:

- *The level at which the contribution was made*
- *The length of time over which the contribution was made*
- *The quality of the contribution made*
- *The value of the contribution to the game in general*

Information **must** be verified by an official of the club, school or NNH committee
(Where service relates to more than one entity, a separate verification must be given)
